

MISSION SERVICES

The mission of Student Health and Counseling Services is to enhance the physical and mental health of students in order to help them achieve academic success, personal development and lifelong wellness by providing an integrated program of quality, accessible, cost sensitive and confidential healthcare services, tailored to their unique and diverse needs and to assist the University community, through consultation and education, to develop a healthy campus environment consistent with UC Davis “Principles of Community”.

SHCS provides a wide variety of medical, mental health and wellness services to all registered UC Davis students regardless of insurance coverage. SHCS is open during regular business hours Monday- Friday. Students calling the main SHCS phone number after hours are given the option to speak to a Counselor or Nurse through an on-call service at no charge. In addition, students have access to online medical, mental health, and psychiatry visits with LiveHealthOnline video conferencing through the SHCS website.

SHCS medical and mental health providers assist students with:

- Documentation letters utilized by students petitioning to modify schedule or drop a class
- Documentation utilized by students seeking accommodations through the Student Disability Center
- Health Clearance Forms for study abroad programs
- Medical Clearances required to participate in academic programs

Other services and support offered to students through SHCS:

- Alcohol, Tobacco and Other Drug (ATOD) Intervention Services including tobacco cessation
- Nutrition services
- Specialty care including psychiatry, podiatry, endocrinology, neurology, sports medicine
- Leadership development opportunities in Health Education and Promotion Services
- Travel clinics
- Case management and referral coordination

SUPPORT CARE

University of California Immunization Policy

Purpose: This policy mitigates the risk of our students contracting vaccine-preventable illnesses that could be acquired in a University facility. To this end, the UC Student Health Directors, supported by the Executive Vice President (EVP) of UC Health and the Vice Chancellors of Student Affairs, have implemented a plan that will ultimately require Incoming Students to provide proof of immunity to respiratory transmitted vaccine-preventable diseases, and undergo screening for tuberculosis.

Requirements: All incoming new, transfer and graduate students, including students in the Veterinary Medicine and School of Nursing programs, are required to meet the UC Immunization and TB Risk Screening requirement.

These include:

- 2 MMR (Measles, Mumps, Rubella) vaccines, or positive titer for each disease
- 2 Varicella vaccines
- 1 Adult TDAP
- 1 meningococcal vaccine (Menactra, Menomune, or Menveo)

Registration Hold Timeline

Students become compliant with the UC Immunization and TB Risk Screening requirement by entering their vaccination dates, uploading a copy of their immunization records, and completing the TB Risk Screening Questionnaire via the SHCS Health-e-Messaging website.

Students who either begin or complete this process before they are scheduled to register for Winter Term 2019 will be able to register without difficulty.

Students who do not log on to SHCS Health-e-Messaging to begin this process will encounter a Registration Hold when attempting to register for Winter Term 2019. The Hold can be removed if the student initiates the process to become compliant.

Students must complete the process and be compliant with the UC Immunization and TB Risk Screening requirement before registering for Spring Term 2019. Holds will not be removed for partial compliance at that time. Requirements will be more strictly enforced next year. In 2019-2020, all new students must become compliant during their first term at school.
